Aboriginal and Torres Strait Islander Health: We aim to consider the health and wellbeing of Aboriginal Torres Strait Islander peoples who identify as LGBTIQ+, inclusive of Sistergirls and Brotherboys. This Panel will consider cultural safety and racism within mainstream and LGBTIQ+ spaces, strategies to improve and how do we support young LGBTIQ+ sistergirls and brotherboys to become leaders.

Kirsten Dezuanni (she/her)

Kirsten Dezuanni is a proud strong Queer Palawa woman and the Social Health Manager at Aboriginal and Torres Strait Islander Health Services (ATSICHS), Brisbane. She is a board member of Walkern Katatdjin Governance Committee and the lead investigator, researcher and author of the ATISHCS Brisbane Safe and Deadly Places Training Program, presented to the **National Deadly Sex Congress** since 2018 for ASHM. Kirsten also holds a Masters in Research and Development (Indigenous Policy Decision Making) and is the author of Safe and Deadly Places training manual for health, medical and human services professionals specialising in safe health services access for indigenous LGBTQI+ mob.

Shakara Liddelow-Hunt (she/her)

Shakara Liddelow-Hunt is a Wajarri Yamatji woman who grew up on Noongar Country. She works at the Telethon Kids Institute as a researcher on the Walkern Katatdjin (Rainbow Knowledge) project, which aims to understand and promote the mental health and social emotional wellbeing of Aboriginal and Torres Strait Islander LGBTQA+ young people.

Jordan Wimbis (he/him)

Jordan Wimbis is a a Wakka Wakka and South Sea Islander man from the Goodnight Scrub in SE QLD. He has a long history in community engagement, activism and advocacy and currently works as Aboriginal Liaison Officer with NEAMI National.

In the first week of March 2021 the findings of the Royal Commission into Aged Care Quality and Safety were made public. AGEISM AND ELDER ABUSE PANEL

2.30pm - 3.30pm (AEST) | Friday 30 April

This session will explore the interrelationship between ageism and elder abuse. The prevalence of elder abuse is currently being studied by the Australian Institute of Family Studies and to date there has been no engagement with LGBTI communities. This panel will explore what researchers need to know to ensure LGBTI ageism and abuse is better understood hence leading to better policy outcomes for our communities. For example, if elder abuse is most commonly perpetrated by the adult children of the older person then what may that look like across LGBTI communities. We will also consider what are the nuances and differences that older LGBTI people may experience.

Paul Van Reyk (he/him)

Paul van Reyk has been a gay activist for the past 40 years and looks forward to continuing to be an activist as he ages. Paul is a father to six adult children, one toddler grandchild with a second on the way. Paul has written extensively on gay activism, gay donoring, and HIV/AIDS. Paul has also featured in ABC and SBS documentaries across his various gay lives. Paul most recently was a member of a panel discussion during the Mardi Gras Festival on LGBTIQA65 - Equality at Every Age.

Bev Lange (she/her) Executive Officer Elder Abuse Action Australia

Brenda Appleton retired in 2009 after 35 years working in the corporate sector and is now heavily involved volunteering with a wide range of community groups, including the LGBTI communities in Melbourne (for more than 20 years). She has expertise in cultural diversity and elder abuse and has undertaken several studies on elder abuse prevalence, primary prevention, risk assessment, management in the context of dementia, and big-data analysis of service responses.

COVID-19 AND LGBTIQ+ OLDER PEOPLE: IMPACT OF THE PANDEMIC IN AUSTRALIA

3.45pm - 4:45pm | Friday 30 April

Different groups of LGBTIQ+ older people experience health disparities that may lead them to be more impacted by COVID-19 and the public health response. This panel comprises researchers sharing initial findings of a mixed-method survey, conducted between August and December 2020, of 394 LGBTIQ+ people aged 60+ on their experience during the COVID-19 pandemic in Australia. Key findings will be reported across the lesbian, gay, bisexual, queer, non-binary, transgender and intersex sub-groups of the sample.

Findings indicate the high level of fear among LGBTIQ+ older people about infection, changes in their internet use, concerns about loneliness and social isolation, and perceptions of how their physical and mental health has changed during the pandemic. Some participants also reported on how their lives have improved during the pandemic, including new opportunities to maintain relationships online, increased wellbeing, less pressure to socialise and a strengthening of some relationships. A 20-minute Q&A session will explore the implications for community and service responses to the pandemic.

Jack Thepsourinthone is a researcher whose endeavours have lead them to undertake various research projects in the aims of improving the quality of life for LGBTQI+, women, migrant, and other minority individuals. B. Psychology (Western Sydney University), M. Research (Western Sydney University), and PhD (current HDR candidate at Western Sydney University). They have over ten years of experience designing and conducting research, as well as collecting and analysing both quantitative and qualitative data (including surveys, focus groups, interviews, observational

research, systematic reviews). Jack Thepsourinthone has experience in quantitative, qualitative, and mixed method research in their own, as well as other, research projects.

Dr Trevor Gates (he/him) University of the Sunshine Coast,

Trevor; Trevor G. Gates is a Senior Lecturer in Social Work at University of the Sunshine Coast. Trevor has experience as a clinical social worker and addiction counselor specializing in practice with sexual and gender diverse people. Trevor is interested in volunteerism and civic engagement in sexual and gender diverse communities.

Dr Tinashe Dune (she/her) Western Sydney University.

Dr Tinashe Dune is a multi-awardwinning Senior Lecturer in the areas of health sociology and public health. She is also a Clinical Psychology Registrar at and a Justice of the Peace for NSW. At Western Sydney University, Dr Dune teaches in the Undergraduate and Postgraduate Health Science programs.

Mark Hughes is Professor of Social Work at Southern Cross University. He has worked as a social worker in health, mental health and aged care settings. Russ believes that older LGBTQ+ people should be more visible and we should celebrated their resilience, strength, knowledge and lived experiences.

Fiona York (she/her)

Executive Officer, Housing for the Aged Action Group

Fiona has been working with older people for almost 20 years in a variety of roles within the community sector, including in elder abuse, community aged care, cultural diversity and most recently, in housing. She has postgraduate qualifications in Community Development, Ethics and Legal Studies and brings a social justice perspective to all aspects of her work. She has worked with Housing for the Aged Action Group since 2016, and has been in the Executive Officer role since May

2018, leading the organisations strong commitment to diversity and advocacy for older people in housing stress.

Regional Advocacy and Education Coordinator, Seniors Rights Service

Margaret is an experienced school teacher and brings her background in education and learning to her current role. She has worked as an aged care advocate/educator with Seniors Rights Service for the past fourteen years. Roy Starkey recently retired following over 50 years of community engagement and support work. He lived and worked in the NR region for over a decade prior to retirement and moving to SE Asia. He returned following unforeseen circumstances and the NR region once again became his base. His professional experiences range from general nursing, to funeral industry, counselling, prison support, care coordination and industry training in ageing, mental health, sexuality and ageing, LGBTI Ageing, and support as

well as working with injecting drug users. Advocating for client rights and acceptance for the diverse communities in which he has worked, he unintentionally he became an activist for the rights of those living with HIV and the broader LGBT communities in both urban and rural/regional areas.

Anthony Venn-Brown OAM (he/him) Founder and CEO of Ambassadors & Bridge Builders International (ABBI)

In a former life, Anthony Venn-Brown was a high-profile Pentecostal preacher, in Australia's mega-churches such as Hillsong. His bestselling autobiography, "A Life of Unlearning", details growing up in a time when homosexuals were imprisoned and mental health professionals treated their "perversion". Turning to God, Anthony spent the next 22 years going through gay conversion "therapy", exorcisms and marriage trying NOT to be gay.

Reverend, Dr Dorothy McRae-McMahon (she/her)

Dorothy McRae-McMahon (born 1934) is a retired Australian Uniting Church minister and activist, formerly Minister at Pitt Street Uniting Church—renowned for its human rights work and local "street level" activism. McRae-McMahon has been a feminist Christian trailblazer since the 1970s.
